### 5. PROPERTY OWNER & REGISTRANT ACKNOWLEDGEMENT

The Waterbury Police Department assumes neither special duty nor liability to respond to an individual alarm system. The Waterbury Police Department, acting in its governmental capacity for the protection of the general public, responds to alarms as the priority of all calls and the daily work permits. Further, to be in compliance with The City of Waterbury Ordinance §91.03 (A) "all existing alarms shall be registered," and §91.99 (A) Penalty, "any person, firm, or corporation found to be in violation of §91.03 A shall be fined **\$100**" Further, §91.03 (F) allows for Three (3) occurrences of false alarms without penalty, per calendar year, and §91.99 (B), incurs a fine of **\$25** for the Fourth (4<sup>th</sup>) occurrence, **\$50** for the Fifth (5<sup>th</sup>) occurrence, and **\$75** for each false alarm thereafter. §91.99 (D) Penalty specifies that any fines levied must be paid within 60 days of notification of the fine. **Accounts with unpaid fines after the 60 day period are deemed delinquent and subject to infraction (State of CT Superior Court ticket) for violation of a municipal ordinance, whereby additional fees and surcharges may be added to the fines noted above.**

The property owner is defined as the owner of record on the property grand list and shall bear responsibility of delinquent fines for any unregistered alarms and occurrences under The City Of Waterbury Ordinance Chapter 91: Alarm Systems.
