

Program Policy

- An individual's personal information will be kept confidential by the Waterbury Police Department unless subject to disclosure by court order
- If necessary, information will be accessed by law enforcement personnel who in performance of their official duties are investigating a crime in the vicinity of where the camera is located.
- Registrants will only be contacted by the Waterbury Police Department if there is a criminal incident in the vicinity of the security camera.

Terms of Use
